*Submissions Open 3 July 2023*

*Submissions Close 25 August 2023*

*Presentation of Winner - 16 September 2023*

## Submission Requirements

---

*All information needs to be submitted via the online nomination form. All entries MUST provide an Overview (300-500 words) which gives a short executive summary of the company and respond to the Award Criteria.*

## Compulsory Attachments

---

All entries must include:

- A testimonial of endorsement which includes name, position, contact number & email
- Company logo\*
- Photo of nominee (for individual awards only)\*

*\*must be high resolution, minimum 300 dpi, JPEG*

## Supporting Materials

---

You may, if you wish, upload additional material to support your entry. However, this is limited to 4 uploads and should not comprise of information that is central to your case – the judges will expect to see this in your main submission.

- Supporting material may include the following:
- PowerPoint
- Video/Image
- Press clippings
- Performance figures

## Key points to note before Submission

---

Before you submit your entry, we ask that you carefully read the category criteria. All entries must be submitted online via the nomination form.

- Ensure you get your testimonial
- Leave yourself enough time
- Please refer to the key dates section for entry deadlines
- All mandatory fields must be completed to allow for submission
- Entries are open to both ICCI Melbourne members and non-members

*ICCI Melbourne reserves the right to refuse nominations submitted after the closing date or those that do not meet the criteria. It is the responsibility of the nominee to ensure all information is correct.*

## Judging Process

---

*Judging of finalists and winners is formally conducted by a panel of a minimum of three judges. The judges will:*

- *Assess each submission in accordance with the award criteria. Only submissions received via the online application process will be accepted and all information received will be kept strictly confidential.*
- *Check all entries meet the correct award criteria.*
- *Declare any conflicts of interest and will be removed from judging or viewing categories where these are identified. Assessment of submissions will be impartial and independent.*
